
**DECLARATION OF THE PROTECTED AREAS NETWORK (NATIONAL MARINE
SANTUARIES OF BIKAR AND BOKAK) REGULATIONS, 2024**

I, Irojlaplap Boklon Zackious, do hereby declare and certify that under customary law and traditional practices of the Republic of the Marshall Islands, I am the rightful holder of Iroj Title to the interests and referenced Atolls of Bikar and Bokak, Republic of the Marshall Islands. I, along with Her Excellency President of the Republic of the Marshall Islands, Dr. Hilda C. Heine, Minister of Natural Resources and Commerce Honorable Anthony M. Muller, Senator of Utrik Atoll Honorable Hiroshi V. Yamamura and Mayor of Utrik Atoll Honorable Tobin Kaiko, do hereby place their respective signatures in solidarity to officiate this National Marine Sanctuaries of Bikar and Bokak Atolls, Republic of the Marshall Islands, acknowledging the commitment to protect a combined total of 48,136.31 km² (18,585.53 mi²) of marine and terrestrial areas surrounding Bikar and Bokak Atolls. Therefore, the *Protected Areas Network (National Marine Sanctuaries of Bikar and Bokak) Regulations, 2024* is hereby declared and endorsed by all signatories to this Declaration.

This Declaration shall supersede any other preceding documents pertaining to this Regulation surrounding Bikar and Bokak.
